# Dr. Lauree Pless, Ripley Town Supervisor

Let me begin by first thanking the Ripley Town Board for their confidence in my ability to serve the community as Ripley Town Supervisor. I am looking forward to working with members of the board, the town and the community.

My educational and employment experiences include over 34 years in Western New York as a School Educator and Administrator. Thirteen of those years I was employed as a School Superintendent, three of those years at Westfield Academy and Central School and 10 years at Amherst



Central School District until my retirement from Amherst 8 years ago. In 2012, I also earned my Doctoral Degree in Educational Leadership and Policy from the University of Buffalo.

Outside of wanting to assist and be actively involved in the Ripley community, I initially decided to run for Town Supervisor because I believe that many of my work experiences parallel the job responsibilities that will be required of me as Town Supervisor. I have had experience in writing and securing grants, collaborating and working with Local, State and Federal agencies and organizing and presiding over various Board of Directors/Trustees. The process of budgeting in both schools and municipalities is also similar. As a School Superintendent, I was responsible for managing a budget that exceeded \$50 million dollars and an organization that employed over 400 individuals.

Although the local town budget is significantly less, the process of managing the funds and allocating resources while being mindful of the impact our expenditures have on tax payers is critical in both these situations. I take this responsibility seriously and understand the impact my role as Town Supervisor has on our community and our tax payers.

# Ripley Town Supervisor Resigns; New Supervisor Appointed

Last November's election saw South Ripley resident, Don Rice, elected to the position of Ripley Town Supervisor, winning by 69 votes over Lauree Pless, along with the election of Jeff Lyons and Calvin Janes to Town Board. On January 18<sup>th</sup> Don Rice, Jeff Lyon and current board member Don Henry, turned in their resignations, Rice and Lyon effective January 19<sup>th</sup>, Henry effective immediately. The reason for the resignations was undisclosed. Jeff Lyon then rescinded his resignation and remains on the town board.

Thursday, January 25<sup>th</sup>, a special board meeting was held to appoint a new Supervisor. With standing room only, board member Lee Swoap read a statement from the by-laws allowing the board to appoint a new Supervisor. After the Resolution was read, Councilman Calvin Janes moved to nominate Lauree Pless, and was seconded by Councilman Jeff Lyon. The motion was passed unanimously.

**WHEREAS**, the Town of Ripley Town Supervisor, Don Rice, submitted his resignation effective <u>January 19</u>, 2024

**WHEREAS**, Town Law Section 64 "General powers of town boards" gives the Town of Ripley Town Board the authority to fill vacancies of elected officials.

**WHEREAS**, Town of Ripley resident, Laura Pless, is willing to serve as the Town of Ripley Town Supervisor.

**NOW THEREFORE BE IT RESOLVED**, that the Town of Ripley Town Board appoints Laura Pless as the Town of Ripley Town Supervisor, effective immediately.

Moved by <u>Councilman Janes</u>, seconded by <u>Councilman Lyon</u>. Roll Call Vote: Mr. Lyon **YES**, Mr. Janes **YES**, Mr. Swoap **YES**. Carried.

"We need to get right to work," Councilman Janes said. "We're a month behind already."

### **Notary Services**


Ryleigh Enterline is now a Notary Public and is available during Town Clerk hours to notarize documents, free of charge.

\*\* Febrary 3rd marks the anniversary of the sinking of the United States Army Transport Dorchester and the selfless acts of four Army chaplains aboard during World War II. The four chaplains, also known as the "Immortal Chaplains" or the "Dorchester Chaplains," represented three faiths: Catholic, Jewish and Protestant.

The Four Chaplains died rescuing civilian and military personnel as the American troop ship SS Dorchester sank on in what has been referred to as the second-worst sea disaster of World War II.
