### A Message From Lauree Pless, Town Supervisor

**Welcome** to spring! The town offices have been busy preparing for the warmer weather as I continue to learn things every day in my new position. I want to thank everyone for their assistance, support and patience throughout the past couple of months.

We want you to be aware of a couple time changes that will be implemented at the Town building. The Town offices will now be open from 8 AM to 4 PM. The Town Board Meetings will now begin at 6:30 PM instead of 7:30 PM. They will continue to be held the second Thursday of each month. You can find these meetings listed on our website, ripleyny.org. We post the meetings on the entrance doors at the Town building.

We also want to inform you that just like many businesses and municipalities in the area, we have decided to close our offices the day of the solar eclipse on April 8, 2024.

Our Clerks' office is excited to announce that beginning April 1, we will now take credit and debit card payments. We will, of course continue to take cash and checks as payment.

Two years ago, in an effort to protect our agricultural properties, the Town decided to take a closer look at the various agricultural and farming properties throughout the town. A stakeholder group of community members that are primarily made up of local farmers was formed. The primary purpose of these meetings was to create a plan that would identify ways in which our community could protect and preserve our agricultural properties while still promoting economic growth in the area. After two years of working on this plan, a preliminary draft was presented at a public meeting held on March 20 at Quincy Cellars. If you were unable to attend this meeting, please note that the final plan should be completed within the next few months and will be made available to the community and the public.

We are also pleased to announce that the Town Court of Ripley has been awarded a grant of more than \$10,000 as part of the Justice Court Assistance Grant through the Judiciary of

New York. The first priority will be securing the back door going into the court with a new bulletproof window. Also, on the list, is the purchase of two file cabinets that will be used to properly store the court records. The grant money will also be used to purchase a large screen television and a mobile cart to bring it into court room when needed.

The town is also looking into updating the phone service. This will allow calls to be transferred to all departments from one number. We hope this will streamline our current system as well as bring our telephone service costs down.

The community should also be aware that the Water/Sewer Superintendent is conducting a survey required by New York State. The purpose of the survey is to check for lead water service lines for each hook-up leading into homes or businesses. Community members are encouraged to fill out the survey as soon as it is received.

Our next regular board meeting will be held on April 11 at 6:30PM.

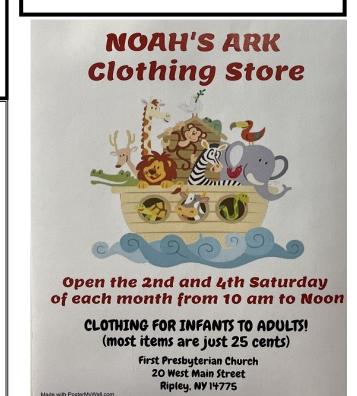
